

SCHOOL BOARD PETITIONS

First day to pick up and circulate petitions: September 20, 2016

Available Monday – Friday from 8:00 a.m. until 4:30 p.m.
County Clerk's Office, 100 South 10th Street, Room 105, Mt. Vernon, IL

The following 1 – 3 must be signed in front of a notary before filing:

1. P-7 Petitions

Minimum of 50 signatures (except Farrington 99 – minimum 41) from registered voters in your school district.

(50 or 10% of total registered voters in school district whichever is less)

2. Statement of Candidacy – NonPartisan (Form P-1A)

Print Name exactly how you want on ballot (no titles)

3. Loyalty Oath – optional (Form P-1C)

4. Statement of Economic Interest Form – file with Jefferson County Clerk's office before December 22nd and receipt is to be attached with petitions.

Please “bind” in the following order:

Statement of Candidacy

Petitions – numbered 1-5, etc. at bottom of page

Loyalty Oath (optional)

Receipt for filing Statement of Economic Interest Form

You should ensure that your name is listed the same way on each petition sheet, Statement of Candidacy and Loyalty Oath (optional).

Petition forms may be photocopies, but must have original signatures, addresses and city.

Each registered voter must sign his/her own name – husbands cannot sign for wives, etc.

You are urged to submit more than the minimum number of signatures to prevent signature challenges.

Every individual who circulates a petition on your behalf (including yourself) must complete the bottom of the petition and sign in the presence of a Notary Public, who will also sign and seal the page.

Once your papers have been filed in my office, you cannot change, alter, delete or add to anything on those documents unless you file a completely new set of petitions with original signatures, so check your forms before you file.

Filing will start at 8 a.m. on Monday, December 12, 2016, and end Monday, December 19, 2016, during office hours. (On the last day to file--12/19/16--we will be open until 5:00 p.m. instead of 4:30 p.m.) All filers for the same position who are here at the opening time or closing hour will be in a lottery to determine ballot placement.
