A presentation was given by Spyglass regarding the opportunity to review all of our telecommunication bills in an effort to save money. An audit will be performed as well as doing an in-depth analysis. Typically 20-25% is saved and no up-front fee is charged. Fees from Spyglass are incurred when savings are realized over a 12 month period paid in one check.

Committee Chairman Ortgiesen has checked with local carriers regarding performing the same service with only feedback received.
